## Reference Guide for Costs

## Seminary-Estimated

Estimates are based on market analysis of local and national prices, including enrollment in a competitive health insurance plan. Housing estimates are reflective of on-campus residency at Denver Seminary. Because estimates are based on market valuations, they are subject to change and fluctuate with the economy.

### Tuition & Fees

<b>Tuition</b> .....	The Th.M. degree is 30 credit hours (\$19,350), so the cost for one of year of this program will be reflective of 15 hours, or \$9,675. Fluctuation in cost that is different from this will need to be evaluated by your Admissions Counselor.
<b>Fees</b> .....	Some courses have special fees for materials and testing, but this will vary.
<b>Books</b> .....	This cost will vary depending on the kinds of books and amount needed.
<b>Supplies</b> .....	Pens, notebooks, folders, backpack/satchel – any supplies for use as a student

### Housing

<b>Rent</b> .....	Single student: based on 2-bedroom apartment w/roommate (\$610/month) Married student: based on 2-bedroom apartment for family (\$1,200/month)
<b>Security Deposit</b> .....	Nonrefundable deposit required to reserve apartment
<b>Renters Insurance</b> .....	Required for on-campus and most off-campus housing
<b>Utilities/Phone</b> .....	Will vary

### Transportation

<b>Public Transit</b> .....	Referring to bus, light rail, taxi, etc.
<b>Automobile</b> .....	Purchase price, insurance, registration, maintenance and fuel costs

### Living Expenses

<b>Food</b> .....	Groceries for home use and occasional restaurant meals (Est. \$250/mo per person)
<b>Clothing</b> .....	Winter clothes and other clothing needs
<b>Laundry</b> .....	Supplies and service costs
<b>Personal Care</b> .....	Hygiene, hair care, beauty/grooming products, etc.
<b>Recreation/Gifts</b> .....	Trips, conferences, local activities, church giving, etc.

### Medical

<b>Health Insurance</b> .....	Required for all international students and dependents (Est. \$160/mo per person)
<b>Eye Care/Dental</b> .....	Generally this is separate from health insurance

### Other Costs (not included in estimated total)

<b>Airfare</b> .....	Referring to costs associated with traveling to/from U.S.; will vary
<b>Laptop/Computer</b> .....	Purchase price, software, and cost of accessories will vary
